#### **BUSINESS**

#### 2025 Budget Approval

Dave McNary, Hennepin County, presented the proposed 2025 budget, totaling \$214,060. Key allocations include \$29,700 for staffing and administration and \$184,360 for contracts. Equal contributions of \$104,755 each will be provided by the Ramsey/Washington Recycling & Energy (R&E) Board and Hennepin County.

Additionally, a one-year, non-renewable contract with Freiberger Law Firm not to exceed \$10,000 was approved to monitor Public Utilities Commission (PUC) dockets related to the 100% clean energy law passed in 2023.

#### **Capitol Hill Associates Contract Amendment**

McNary requested approval of a \$91,000 amendment to the Capitol Hill Associates lobbying services contract. The amendment reflects increased legislative work anticipated in 2025, including a focus on Extended Producer Responsibility (EPR) and other waste-related policy initiatives.

#### 2025 State Legislative Platform

#### Introduction to Melissa Finnegan as New Strategic Partnerships Manager

Trista Martinson, R&E executive director, introduced Melissa Finnegan to the board, highlighting Finnegan's professional background, expertise in waste management and energy policy and her role in supporting the board's initiatives.

#### **Wood Waste Study**

Caleb Johnson, Washington County, presented that phase two of the wood waste study with Cambium Carbon is underway, focusing on both immediate and long-term solutions for managing wood waste.

#### **Hazardous Waste Generator Training**

Johnson presented hazardous waste training materials are being translated into Hmong to improve accessibility for non-English speakers.

#### **Commercial Recycling Study**

Johnson presented ongoing research to improve methodologies for measuring recycling and reuse in commercial sectors.

The board discussed addressing lithium battery disposal challenges, including implementing battery return policies and enhancing public education on proper disposal.

#### **EXECUTIVE SUMMARY:**

The Amended and Restated Joint Powers Agreement (JPA) of the Partnership on Waste and Energy (Partnership) states the Governing Board shall include the Chair and Vice Chair of the Ramsey/Washington Recycling & Energy (R&E) Board and a commissioner appointed by Hennepin County, resulting in a representative commissioner from each of Ramsey, Washington and Hennepin Counties. Partnership Board members serve two-year terms.

- The 2025 R&E Board members on the Partnership Board are Ramsey County Commissioner Mary Jo McGuire and Washington County Commissioner Fran Miron.
- Commissioner Debbie Goettel was appointed by the Hennepin County Board at their organizational meeting on January 2, 2024, for the first year of the 2024-2025 Partnership Board term. Commissioner Goettel will serve the second year of her term in 2025.
- Since leadership of the Partnership, for Chair and Vice Chair, rotates annually by county name in alphabetical order, the 2025 Partnership Chair is Washington County Commissioner Fran Miron, and the Partnership Vice Chair is Hennepin County Commissioner Debbie Goettel.

The Partnership's alternate board members serve a two-year term through 2026.

• T	Iternates from the R&E Board for the 2025-2026 term are Ramsey County Commissioner Kelly filler and Washington County Commissioner Karla Bigham.  The alternative for Hennepin County for the 2025-2026 term is Hennepin County Commissioner eather Edelson.

#### **EXECUTIVE SUMMARY:**

#### a. Wood Waste Management Project Update

A project on the management of wood waste was initiated in 2024 as a follow-up analysis to the Partnership's 2022 report outlining the growing volumes of wood waste within Partnership counties. Both the 2022 analysis and follow-up analysis were prepared by staff at Cambium, a public benefit corporation on a mission to enable a regenerative cycle of urban wood reuse, who will provide a presentation of the 2024 analysis. Partnership staff will provide an update on this project.

#### b. Joint Powers Agreement Update

Partnership staff have been undertaking a review of the existing Joint Powers Agreement and will provide an update on this effort.

### c. Legislative Session Preview

The 2025 regular legislative session began on January 14, 2025. Partnership staff will provide an update on activities and issues that may be addressed in the months ahead. The State Constitution requires the legislature to conclude business by May 19, 2025. The legislature must agree to a biennial budget by June 30, 2025.

PWE supports policies that create effective incentives and prioritize resources in alignment with policy goals.


PWE supports state funding at levels that allow local government to carry out statutory responsibilities.
